The vancouver.bst bibliographic style file (for $L^{4}T_{E}X/BibT_{E}X$) is generated with the docstrip utility and modified manually to meet the "Uniform Requirements for Manuscripts Submitted to Biomedical Journals" as published in N Engl J Med 1997;336:309-315. (also known as the Vancouver style). This specification may be found on the web page of the International Committe of Medical Journal Editors.¹ The following samples of reference citation formats were taken from the National Library of Medicine web site to show what works and what does not (yet).²

In order to meet all citation formats, several entry types – such as **@map**, **@patent**, **@dictionary** and **@webpage** – and fields – such as **inventor**, **assignee** (for patents), **cartographer** (for maps), **part**, **lastchecked**, and **updated** (for webpages). For proper use of these entries and fields I refer to the vancouver.bib file included with the package.
